



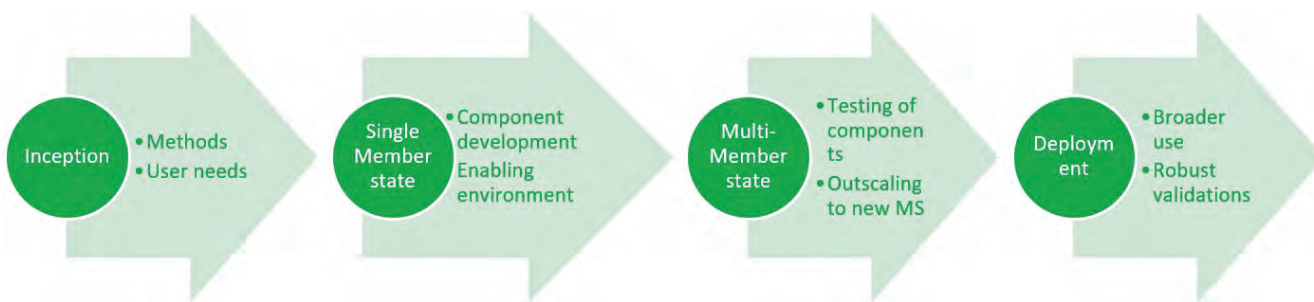
# NEWSLETTER

From November 2020 to October 2021 NIVA digital innovations from each Use Case are being tested by multi-Member States as Large Scale Pilots in order to validate NIVA concept. Corresponding webinars have been held, relevant documentation published and NIVA mid-term review was a success. NIVA will continue the focus on cross Member State collaboration and co-design while grasping the opportunity to facilitate uptake of innovations by involvement of outside-NIVA Paying Agencies and other partners. Through this newsletter we hope to provide you an overview of the developments and achieved results to date.

## QUICK OVERVIEW: WHAT IS NIVA ?

NIVA implements an iterative learning approach where applications of Use Cases and the enabling environment are gradually built up, benefiting from “cross-fertilisation” and mutual improvements: Development and testing of digital innovations through Open-Source Software Components and Large Scale Pilots; Enabling environment through Harmonization, Knowledge Information System and Innovation Ecosystem.

This process aims for full deployment of the Use Cases as Large Scale Pilots in months from 2021-06 to 2022-06 with each digital innovation been deployed in multiple IACS systems of PAs as the ultimate validation of the project, and thereby providing the insights required for further use. Alongside the deployment of the pilots, also the enabling environment will be established demonstrating the longer term added value in terms of knowledge production and ecosystem dissemination.



## WHAT ARE THE CURRENT NIVA ACHIEVEMENTS?

NIVA aims to modernise IACS by making efficient use of digital solutions and e-tools, by creating reliable methodologies and harmonised data sets for monitoring agricultural performance while reducing administrative burden for farmers, paying agencies and other stakeholders. Already 2 years of NIVA implementation have passed and it is time for reflection on the main achievements towards the main challenges and objectives, which is summarized in the tables 1 and 2.

## SERIES OF WEBINARS ON NIVA RESULTS

For the dissemination of NIVA goals, plans, achieved mid-term results and other materials to the growing network of NIVA stakeholders the original plan was to have half-yearly stakeholder forum meetings. The first one took place on November 2019, but the planned ones in 2020-2021 were cancelled due to pandemic restrictions. Instead, NIVA have organised a series of webinars. The webinars each dealt with a dedicated topic and each time at least one of the NIVA Use Cases were linked to the topic and showcasing what the NIVA products could help to deliver. Participant numbers grew towards 150. Besides the usual participants from Paying Agencies, also a growing group of agri and tech businesses, NGOs, Farmer groups and policy makers were attending the NIVA webinars. NIVA built visibility and trust on openness, honesty and ability to connect and unite different stakeholder groups.
