On the 26th and 27th of September 2022 NIVA organised a Stakeholder Forum on the Greek island of Santorini. This Stakeholder forum was mainly intended for Paying Agencies to get a good overview of the work the NIVA project has conducted since June 2019. We were happy to welcome more than 100 participants, of which 80 attended in-person. The NIVA innovations were presented and a lot of informal networking also took place discussing the work of NIVA.



PROJECT MEETING (SANTORINI, GREECE: 28 AND 29 SEPTEMBER 2022)

After the NIVA Stakeholder Forum the members of the NIVA project remained in Santorini to attend the NIVA Project meeting on 28th & 29th. During these two days NIVA participants focused on how to successfully conclude the project. But more importantly to brainstorm and discuss how cross organisation cooperation could continue after the NIVA project ended.

The output of the project meeting will be used for a note for continuation. Key elements of this proposal will be to include more partners, with more focus, long-term development and creating an incubation space for innovation. NIVA IN VISUALISATIONS

Many of you already saw some of the NIVA Use Case work in visualisations. As a picture can say more than a thousand words NIVA is happy that all 9 Use Cases have been visualised. 
NIVA PRESENCE ON THE EUROPEAN STAGE

As the work of NIVA becomes more and more tangible the momentum is there to share this. Although the Santorini meeting was an excellent platform to do this, NIVA has also been active in reaching out to a broader audience.

From the 12th to the 14th of September NIVA was present at the MARS conference that took place in Barcelona. The NIVA project was presented as well as the evolution of IACS through AMS and beyond. On the Poster Session NIVA posters were put up on NIVA's Use Cases UC1B (agro-environmental monitoring) and UC1A (Decision Support System).
